### Minutes for Meeting on November 11, 2010

Commissioner Dunn made a motion to accept the minutes as published. The motion was seconded by Commissioner Renninger and passed without opposition.

### Treasurer's Report

John Price read the treasurer's report for November, 2010 and copies were made available for all people in attendance. Commissioner Lynch made a motion to approve as read, which was seconded by Commissioner Dunn. The motion passed without opposition.

### Warrants

The warrants for November, 2010 were then read by John Price, and copies were made available for all people in attendance. Commissioner Dunn made a motion to approve payment of the warrants, which was seconded by Commissioner Lynch. The warrants were approved unopposed.

### Certificates of Achievement

In recognition of Police Chief Redman and Sergeant Skaggs' effort in obtaining accreditation for the Police Department, the City of Hurstbourne Acres presented both men with certificates of achievement.

### Police Report

Police Chief Redman reported as follows:

- 235 police coverage hours from 11/11/10 to 12/9/10,
- 2 arrests,
- 3 citations,
- 2 reports,
- 3 accidents,
- 11 traffic stops,
- 455 police/public contacts

In other news, it was noted that the new striping is complete on the police vehicles. Also, a new video in-car camera system was awarded to our Police Department by Highway Safety in a raffle. This is valued at \$6000. As a safety tip during this holiday season, it was recommended that packages purchased be kept out of sight, and to always be aware of your surroundings. The Police Department expressed their thanks and appreciation for the work done over the years by outgoing Commissioners Dunn and Lynch.

### Attorney's Report

Attorney Emery had nothing to report.

### COMMITTEE REPORTS

#### Police

Along with previous suggestions to keep packages hidden, particularly at this time of year, Commissioner Dunn recommended caution when disposing of boxes for large-ticket items. Regarding potential snow fall, residents were reminded that any projected snow fall of 1" or more requires that vehicles be relocated from the street so that snow plows can do their job. After a discussion about providing a Christmas bonus for our 3 police officers, Commissioner Hardin made a motion to give each officer \$100. The motion was seconded by Commissioner Renninger and passed without opposition. Finally, it was mentioned that the snow removal contract has been approved, same contract as last year.

### Award to Police Commissioner Dunn

Mayor Fore presented Marty Dunn with his badge as Police Commissioner of Hurstbourne Acres, mounted on a plaque,

in appreciation of the many years of service he provided to this city.

### Roads and Lighting

Commissioner Lynch advised of the vandalism to the Blowing Tree street sign. There was also mention of many of the pole lights malfunctioning in the city (burning during the day). It was reported that there is a discrepancy between LG&E and our records as to the number of light poles in our city. Finally, it was noted that for several years, LG&E has been billing the City of Hurstbourne for light poles actually belonging to the City of Hurstbourne Acres. How this will be resolved has not yet been determined.

### Parks Commissioner

Commissioner Hardin reported that 1 of the 3 waste cans in the park needs to be emptied. No other news.

### Sanitation

Commissioner Renninger advised that one house on Woodfield and one house on Haviland, both scheduled for backdoor service, were missed twice this past month. This is being corrected.

### OLD BUSINESS

#### Miscellaneous

- The leaf pickup is now complete and a bill should be provided shortly,
- City computer has been repaired from a recent 'crash',
- In reply to a suggestion for a change to the Christmas decorations, that can be adjusted during the budget process for the fiscal year beginning 7/1/11,
- 1<sup>st</sup> reading of the ordinance regarding alcohol consumption in the park has been postponed until next year,
- Regarding the city project to provide residents with a way to dispose of old paint, household chemicals, etc., Mayor Fore has asked Police Chief to put together the details. Commissioner Hardin has received additional information suggesting the difficulty of going forward with this project.

Mayor Fore expressed his thanks to this current group of commissioners for their dedication and hard work to make this city a better place to live.

There being no further business or discussion, the meeting was adjourned.
