## **Police**

It was great to see many of you at the City Picnic on the 24th. This was my 4th City Picnic as a member of your Police Department and I think that our City Commissioners really outdid themselves this year. If you were not able to attend, you missed out on a beautiful day and a fantastic event.

Now that October is here, it means that Halloween is just around the corner. Below are some tips for trick-or-treaters, home owners and motorists from the American Academy of Pediatrics.

### **COSTUMES:**

- Plan costumes that are bright and reflective. Make sure that shoes fit well and that costumes are short enough to prevent tripping, entanglement or contact with flame.
- Consider adding reflective tape or striping to costumes and trick-or-treat bags for greater visibility.
- Because masks can limit or block eyesight, consider non-toxic makeup and decorative hats as safer alternatives. Hats should fit properly to prevent them from sliding over eyes.
- When shopping for costumes, wigs and accessories look for and purchase those with a label clearly indicating they are flame resistant.
- If a sword, cane, or stick is a part of your child's costume, make sure it is not sharp or too long. A child may be easily hurt by these accessories if he stumbles or trips.
- Obtain flashlights with fresh batteries for all children and their escorts.
- Do not use decorative contact lenses without an eye examination and a prescription from an eye care professional. While the packaging on decorative lenses will often make claims such as "one size fits all," or "no need to see an eye specialist," obtaining decorative contact lenses without a prescription is both dangerous and illegal. This can cause pain, inflammation, and serious eye disorders and infections, which may lead to permanent vision loss.
- Teach children how to call 9-1-1 (or their local emergency number) if they have an emergency or become lost.
- Exercise extra caution when driving during Trick-or-Treat hours. Foot traffic in residential areas will be increased and small children may become excited and dart into the roadway. Please drive safely.

The regular meeting of the City Commission was called to order at 6:30 PM on September 21, 2017 at the meeting room of the Hurstbourne Acres City Hall/Police Department, 1916 Hurstbourne Circle, Louisville, Kentucky, with the following persons present;

**August 10, 2017 Minutes**

Commissioner Nichols made a motion to accept as submitted. The motion was seconded by Commissioner Renninger and carried without opposition.

**Treasurer's Report**

Sharon Hollkamp read the report for August, 2017 and copies were made available for all people in attendance. After a discussion, Commissioner Renninger made a motion to accept the report as presented. The motion was seconded by Commissioner McAllister which carried unanimously.

**Warrants**

Sharon Hollkamp read the warrants for August, 2017 and copies were made available for all people in attendance. A motion to accept the warrants as outlined was made by Commissioner Nichols and seconded by Commissioner Renninger. The motion carried unopposed.

Police Chief Griffin reported on the following for August, 2017;

August, 2017 Highlights;

- All officers completed monthly KLC recommended training,
- The 1 offense report was for a theft from Office Depot,

- Explorer and Taurus are in good working order.

**Attorney's Report**

Steve Emery reported that as developed by Commissioner Renninger, he prepared a revised nuisance ordinance. Also, regarding the sidewalk project on Blowing Tree Road, he has sent to Commissioner McAllister and Mayor Fore a draft complaint letter for 'imminent domain'. He is awaiting the Mayor's review and authorization to proceed.

## COMMITTEE REPORTS

### **Parks**

Commissioner Eskridge updated the Commission on the details of the upcoming city picnic including the prizes and gifts to be given out. In other news, due to other planned projects by MSD, the retention basin ditch clean out is no longer a priority. It is now scheduled to be completed in January, 2018. As KLC underwrites our City's liability insurance, they have sent a letter outlining 8 potential liability problems in the Park all of which we had previously identified, and agreed to resolve. To provide a long lasting solution to the liability issues, Commissioner Eskridge has suggested replacing the balance of the playground equipment. With 2 proposals already obtained, he has applied for a matching funds grant (up to \$45,000). The grant does not include labor or surface costs. Grant Line Nursery has replaced the trees in the Park. They will include gator watering bags. Commissioner Eskridge stated that these trees are better than the ones there previously. Lastly, the geese problem was mentioned. A suggestion was made to fence the sand area of the playground and/or use wolf cut outs, but no decision was made.

### **Sanitation**

Commissioner McAllister advised that he spoke to the manager of the Meadows Apartment Homes again about the construction of a sidewalk. Apparently, he is opposed to the sidewalk, but provided Commissioner McAllister with the phone number of his boss. Messages have been left, but has not returned any calls. Commissioner McAllister asked about placing traffic control devices (warning signs and markings) on the north end of Hurstbourne Circle. The blocked intersection makes it very difficult to get into and out of the street, particularly at rush hour. After a discussion, and with the approval of the Mayor, Commissioner McAllister will do more research and contact District Representative Marilyn Parker's office.

### **Streets**

Commissioner Nichols reported on a resident of Cardwell Way who installed a satellite dish in opposition to the ordinance. Although the dish has now been moved to the back, it is still visible from the street, and neighbors have complained. It was decided that the resident will be requested to move the dish again to comply with the satellite dish ordinance. In other news, she stated that the landscaping of the city entrance signs will begin in 2 weeks. Concerned about the cost of the City's land phone lines through AT&T, Commissioner Nichols suggested that Spectrum may be able to provide the same service at a lower cost. Mayor Fore asked her to contact Spectrum and get more information. Lastly, Mayor Fore received a call from Precision Concrete Cutting. The representative completed an unsolicited survey of our entire city which included cracking sidewalks (Bunsen Parkway), and overgrowth on Blowing Tree Road and Hurstbourne Lane. She stated that all of the issues could be fixed for a cost of \$7450. Mayor Fore said that he would mention it this meeting, and thinks, at the very least, the City should consider the potential liability if no action is taken. A copy of the survey will be provided to each of the commissioners.

### **Police**

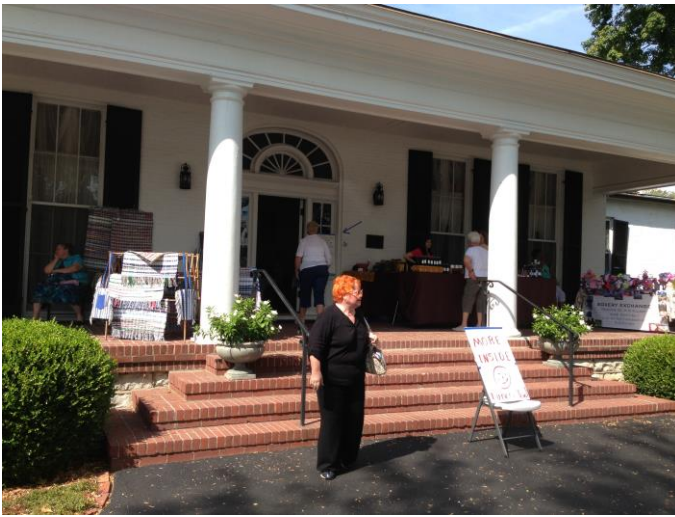

Newsletter As a result of the complaints from residents about the inconsistency of receiving the Hurstbourne Post over the last few months, and no one receiving the City newsletter in September, a decision was made to terminate our relationship with Alicia Boardman. Mayor Fore advised that he would contact her tomorrow. Commissioner Eskridge said that as a temporary measure, he would serve as the newsletter editor until a replacement can be found. There being no further business or discussion the meeting was adjourned.
