Ordinance No. 3
Series 2000

Ordinance No 3, Series 2000, establishing the 2000-2001 Tax Rate for Ad Valorem taxes on all real and personal property in the City of Hurstbourne Acres, Kentucky, and the levy of an Ad Valorem taxes thereon for the general operating purposes of the City for the fiscal year of July 1, 2000 to June 30, 2001.

Whereas the City of Hurstbourne Acres, Kentucky is authorized and empowered to fix the Ad Valorem tax rate, and the due and delinquency dates, and to levy and collect said taxes, and

NOW THEREFORE BE IT ORDAINED BY THE CITY OF HURSTBOURNE ACRES, KENTUCKY:

Section 1: January 1, 2000 is set as the assessment date for real and personal Property subject to taxation within the boundaries of the City of Hurstbourne Acres, Kentucky.

Section 2: The city Clerk and Treasurer are directed to obtain a true copy of the assessment of property within the corporate limits of the City of Hurstbourne Acres, Kentucky and to make out tax bills and mail same. Each tax bill shall show the property and the improvements thereon separately, the name of the supposed owner or owners, and the Ad Valorem tax rate and the tax due for the fiscal year.

Section 3: Upon delivery of such bills, the Treasurer shall have the responsibility of supervising the collecting of same and all remittances shall be made to the City Treasurer as required by law. Collection of delinquent taxes shall be made in the manner prescribed by law.

Section 4: The Ad Valorem tax rate for the year is fixed at 17 cents per \$ 100 valuation of property assessed for taxation, said tax shall be due as follows:

July 1, 2000 to July 31, 2000, face amount; after August 1, 2000, face amount plus 6%, plus 1% interest per month until paid. Penalties are cumulative.

Section 5: The cost of collection, including a reasonable attorney's fee shall be assessed to any delinquent taxpayer.

Section 6: The tax payment shall be made as follows:

Section 7: The proceeds of this tax are to be used as follows:

17 cents (.17) per \$ 100 of valuation, being the entire amount of said tax, plus interest or penalties collected thereon, for general operation of the City.

Section 8: The Ordinance shall become effective upon its passage and publication.


